CONSENT WAIVER

The Fox Valley Animal Welfare League Spay Neuter Clinic employs licensed, well experienced veterinarians and trained staff members in addition to using the highest quality materials for every procedure performed.

It is important to understand the risk of surgery as well as anesthesia. Although extremely low, the risk of death is always present, just as it is for humans that undergo surgical anesthesia.

As the owner or agent of this animal, I authorize the Fox Valley Animal Welfare League to perform the surgical procedure as scheduled. I authorize the veterinarian to administer any treatment that may be deemed medically necessary during the course of the procedure.

I release and indemnify all Fox Valley Animal Welfare League employees, volunteers, and agents from all liability.

I understand that the veterinarian maintains the right to refuse to perform surgery on any animal for whom surgery is deemed a health risk.

Animals not picked up by 5:30 pm will incur a \$1 per minute late fee until picked up.

I understand that this dental cleaning is considered preventative care and that major dental work, including complex extractions, are NOT considered preventative care. The dental cleaning fee is \$200.

I understand that the standard of care requires x-rays for dental work outside the normal cleaning procedure and that the Fox Valley Animal Welfare League does not provide this service.

I understand that if there are loose teeth that need to be removed and can be extracted or pulled without surgery that this service will be performed, the fee for this is \$5 for every tooth removed.

I understand that if there are teeth that need to be removed that require surgical extractions that the surgeon has the discretion to remove those teeth that they feel can be comfortably removed without x-rays. The fee for this is \$20 for every tooth surgically removed. Those teeth that cannot be removed comfortably or are determined to pose additional risk without the presence of x-rays will not be removed and will need to be referred to a specialist as complications can occur including retained roots and jaw fracture.

I understand that extractions are not an optional choice in performing dental procedures. Rotting teeth and severe dental disease can not be taken care of with a simple cleaning.

I further understand that during the cleaning procedure, if there are major complications found, the veterinarian will diagnose and recommend treatment options for any services that cannot be performed while under our care.
